 ADMIX AD1 Approximately 50% aqueous dispersion copolymer of vinyl acetate ethylene with organic additives.

Handle in well ventilated areas. Avoid eye contact and prolonged or repeated skin exposure. Avoid ingestion and unnecessary inhalation of material. Good ventilation or extraction should be provided when mixing diluted ARDEX ENDURA ADMIX AD1. with the selected ARDEX ENDURA cement based adhesive. The adhesive paste formed after mixing is alkaline and contact with unprotected parts of the body should be avoided. It is recommended that eating, smoking or drinking is not permitted. Exercise good personal hygiene before breaks and end of work.
