HUMAN HEALTH

When the cement based powder is mixed with water or admixture, a strongly alkaline paste is produced. Cement based products may, until set, cause both irritant and allergic contact dermatitis. Irritant contact dermatitis is due to a combination of the wetness, alkalinity and abrasiveness of the constituent materials. Allergic contact dermatitis is caused mainly by the sensitivity of the individual's skin to hexavalent chromium salts.

COMPOSITION COMMENTS

The White adhesives contain a reducing agent to ensure that the CrVI content of the adhesive remains below 2ppm during the defined shelf life of the adhesive.

4. FIRST-AID MEASURES
