HUMAN HEALTH

When the cement based powder is mixed with water strongly alkaline paste is produced. Cement based products may, until set, cause both irritant and allergic contact dermatitis. The White adhesives contain a reducing agent to ensure that the CrVI content of the adhesive remains below 2ppm during the defined shelf life of the adhesive.
