HUMAN HEALTH

When the cement based powder is mixed with water or admixture, a strongly alkaline paste is produced. Cement based products may, until set, cause both irritant and allergic contact dermatitis. COMPOSITION COMMENTS

The Grey adhesives contain a reducing agent to ensure that the CrVI content of the adhesive remains below 2ppm during the defined shelf life of the adhesive.

4. FIRST-AID MEASURES
